PURPOSE:

ICON is committed to designing, manufacturing, delivering, and supporting a high-quality Light Sport Aircraft. This Service Letter is to notify owners of an upgraded Wing Hang Pin made from a material that reduces fatigue and increases the life of the pin. This notification includes instructions for replacing the Wing Hang Pins.

Special tools, fixtures, or test equipment:

1. Helical thread insert tooling (as needed).

INSTRUCTIONS:

- 1. _____ Reference ICON A5 Maintenance Manual (P/N ICA000833) for the removal of the existing wing hang pins. If during removal, Helicoil was damaged then follow the step below:
 - a. _____ Screw the insert (91732A213) onto the tool and drive it a quarter to half-turn below the material's surface (the bottom surface of the receptacle that the pin threads into). No element of the helicoil should be protruding from the receptacle surface.

NOTE: Do not apply any Tef-Gel or Lubricant to the new wing hang pins.




Figure 1: Wing Hang Pin Install

- 2. _____ Apply Loctite 243 onto the threads of the new wing hang pin, Figure 1.
- 3. ____ Install new wing hang pins (ICA013760) into the Horizontal Tail.

4. ____ Torque wing hang pin to **150 inch-lb**.
