- b. Remove any pages associated with the MRA01059-POH-A supplement.
- 2. Transcribe the Airplane Registration Number and Airplane Serial Number to the new Cover Page exactly as they appear on the current one.
- 3. Ensure that all data in the Weight and Balance Record is transferred to the new POH. Failure to transfer this information could lead to compliance issues and the inability to properly maintain the airworthiness of the aircraft.
- 4. Review the Record of Revisions and/or any revisions added by hand due to an MRA. Transfer any applicable revisions to the new POH. Contact ICON with any questions.
- 5. Verify that all POH Chapters have a Change ID in the footer that matches the List of Effective Chapters.
- 6. Sign (or initial) next to the 'Added By' column cell corresponding to this Handbook Revision at the top of the Record of Manual/Handbook Revisions.
- 7. Discard all of the old pages removed from the handbook during the update process.
- 8. Take some time to review and familiarize yourself with the content of each changed Chapter.
