PURPOSE:

This directive is issued to remind the ICON community of the importance of sourcing aircraft components exclusively through authorized ICON Aircraft channels. ICON has identified that specific components are being offered for sale via unauthorized third-party online platforms. These components are being offered illegally, as they have been obtained through illegal means and do not carry any guarantees or assurances.

The ICON A5 is an S-LSA accepted by the FAA based on ASTM consensus standards. Per 14 CFR §91.327(b)(1), no person may operate an S-LSA unless it is maintained in a condition for safe operation and in accordance with the manufacturer's (ICON's) instructions.

The use of unauthorized parts presents the following risks:

- **Loss of Traceability:** Per ASTM F2972, ICON's Quality Assurance System governs the production and approval of the entire aircraft configuration. Parts sourced outside the official supply chain lack a verified chain of custody, making their origin, material quality, and revision status unknown.
- **Non-Compliance:** Per ASTM F2483, maintenance must be performed using parts that are verified to meet the manufacturer's specifications. Installation of parts without a valid Certificate of Conformance (CoC) or documented traceability, including those sourced through unauthorized channels, constitutes the use of a Suspected Unapproved Part (SUP), which may invalidate the aircraft's airworthiness certificate.
- **Operational Risk:** Components not vetted through ICON's quality system—regardless of their perceived criticality—may have undisclosed defects or damage that could lead to mechanical failure.
